Personal History Statement Instructions

Employees are exposed to confidential personal and law enforcement sensitive information. A thorough background investigation is required to properly evaluate the suitability of applicants for employment with the Oak Ridge Police Department. Although it is an achievement to reach the background phase of the hiring process, this is still a competitive process and does not, in any way, guarantee selection.

These instructions are provided as a guide to assist you in properly completing your Personal History Statement. <u>It is essential that the information is accurate in all respects</u>, so please read all instructions carefully before <u>proceeding</u>. The Personal History Statement will be used as a basis for a background investigation which will determine your eligibility for becoming an employee.

- 1. Your application must be printed legibly in **BLACK INK** by the applicant or typed. Answer all questions truthfully and accurately.
- 2. If a question is not applicable to you, enter N/A in the space provided.
- 3. Avoid errors by reading the directions carefully before making any entries on the form. Be sure your information is accurate and in proper sequence before you begin.
- You are responsible for obtaining correct and full addresses. If you are unsure of an address, personally verify before making that entry on this document. Errors will not be viewed favorably. <u>ALL ADDRESSES</u> MUST BE COMPLETE WITH ZIP CODES.
- 5. If you need additional space for your answers, attach an additional sheet or sheets as needed. Be sure to indicate what question number and page the supplemental refers to.
- 6. An accurate and complete form will help expedite your investigation. **Omissions or falsifications** will result in **disqualification.**
- 7. You are responsible for furnishing any changes and / or updating your application as needed, such as address changes or telephone changes in writing.
- 8. Any candidate submitting an incomplete application <u>WILL NOT BE CONSIDERED FOR EMPLOYMENT</u>. Your application <u>will be evaluated on completeness and neatness</u>.
- 9. <u>All documents requested must be submitted with the application</u> (Photocopies are acceptable in most cases). Required documents vary according to the position being sought, and the history of the applicant.

	I have never had a military court martial that resulted in a dishonorable or bad conduct discharge.

DISQUALIFICATION

There are very few <u>automatic</u> disqualifiers. Even issues of prior misconduct, employee terminations, and arrests are usually not, in and of themselves, automatically disqualifying. However, <u>deliberate misstatements or omissions</u> can and often will result in your application being disqualified, regardless of the nature or reason for the misstatements / omissions. In fact, the number one reason individuals "fail" background investigations is because they deliberately withhold or misrepresent job-relevant information from their prospective employer.

This personal history statement is a governmental document. Be truthful, as there are criminal consequences for lying on a governmental document.
