Item 1 **Call to Order**

Meeting was called to order by Mayor Paul Hullar at 6:00 PM. Present were Council Members, Janelle Davis, Scherri Holmes, Nena Langford, Rolando Guzman and Mayor Pro Tem Jimmy Quick. Chief Bill Weatherly and City Secretary Karen Stacey were also in attendance.

Item 2 **Citizen Input**

Item 3 **Update on Court Activities of January 2025 Court**
