Item 1 **Call to Order**

Meeting was called to order by Mayor Al Rudin at 7:00 PM. Present were Council Members Rolando Guzman, Janelle Davis, Jimmy Quick, and Scherri Holmes. Nena Langford was absent. City Secretary Donna Sprague was in attendance.

Item 2 **Pledge**

Council stood and said the pledge.

Item 3 **Citizen Input**

There were no citizens present.

Item 4 **Approve Payments of June 2021 Bills**

Motion was made by Jimmy Quick and seconded by Rolando Guzman to approve payment. All being in favor, motion carried.

Item 17 Mayor/Council Items of Community Interest and/or Items for Future Council Considerations (No Action to be Taken)


No comments were made.
